Purchase of “Power Analyzer for Computer Test Lab and Purchasing Instruments for the Instrument Bank of SLSEA”

Sri Lanka Sustainable Energy Authority is maintaining an instrument bank to facilitate energy measurements during energy audits or any energy consultancy services. These instruments are hired for outside parties and used by the authority during energy audits. Since measuring of parameters is critical in energy auditing activities, having a well-maintained instrument bank is utmost important. SLSEA as one of the focal government institute who is having a well-maintained instrument bank, need to calibrate the existing instruments on time and purchase new advanced instruments to meet the requirements of the customers.

1. The Chairman, Department Procurement Committee invites bids from suitable companies under National Competitive Bidding for **Purchase of “Power Analyzer for Computer Test Lab and Purchasing Instruments for the Instrument Bank of SLSEA**
2. Interested bidders can inspect/download the Bid document from the link <http://www.energy.gov.lk/index.php/en/procurement>. Interested parties who wish to submit their bids shall make a non-refundable cash payment of LKR 1000.00 to SLSEA’s cashier.
3. A copy of the above payment receipt shall be submitted along-with the bid. Bids without a copy of the payment receipt will be rejected.

Sealed bids marked ‘**Purchase of Power Analyzer for Computer Test Lab and Purchasing Instruments for the Instrument Bank of SLSEA**’ - SEA/PD/SME/26-2025 and SEA/PD/ISS/27-2025’ on the top left-hand corner of the envelope shall be sent to reach the Chairman, Department Procurement Committee, Sri Lanka Sustainable Energy Authority, 80, Sir Earnest De Silva Mawatha, Colombo 07, through registered post or deposit in the tender box placed in SLSEA office at above address on or before **10.30 a.m. on 08th October 2025**. Late bids shall be rejected. Bids will be opened soon after the closing time. The bids shall be valid up to 23rd December 2025 and bids should be accompanied by a Bid Security of LKR 170,000.00 either as a cash deposit to SLSEA cash counter or a Bank guarantee as specified in Bid document, which shall be valid until 23rd January 2026
5. Bidders are hereby informed that the provisions of public contracts act no. 3 of 1987 are applicable to tenders total cost exceeding Rs 5 million. Accordingly all partners involved in the aforementioned tender are required to strictly abide by the said act throughout the duration of contract and required to register himself with the registrar of public contract and shall submit the dully completed registration certificate.
